THE SANCTUARY AT AVONDALE GAZEBO RESERVATION AGREEMENT

1. The undersigned agreement is between The Sanctuary at Avondale HOA and _____
2. A deposit of \$100.00 (in the form of a personal check) must be received by the Management Company within ten (10) business days prior to date of event. If the gazebo and surrounding areas are left clean and undamaged on the same day of the event, the deposit will be refunded the next business day. All cleanup and damages will be the responsibility of the reserving party.
3. Reserving party must be at least 18 years of age and a current member of the Association or Registered Resident within The Sanctuary at Avondale Homeowners Association. The reserving party must be present on site during the entire event.
4. Reserving party is responsible for the conduct and behavior of their group
5. One (1) adult must be present for every 10 attendees age 17 and under.
6. Proof of insurance must be provided within ten (10) business days for any inflatables.
7. No alcohol or glass containers will be present at the event
8. Reserving party shall not prohibit participation bases on race, religion, gender, national origin or disability.
9. Reserving party is responsible to putting up notice of reservation on the gazebo on the morning of the event.
10. The noise level must be kept in a manner to respect all neighbors.
11. Failure to comply with the terms of the Reservation Agreement will result in forfeiture of the right to use the gazebos.
